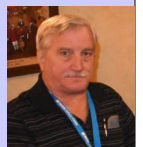

For those who have a trip planned, or are thinking about such a trip, to the National Corvette Museum, please find below a brief listing of the exhibits, galleries and other activities currently available at the Museum and Motorsports Park. More information on these events can be found at the museum website, corvettemuseum.org, or the motorsports park at motorsportspark.org.

MUSEUM EXHIBITS

-Ground to Sky: The Sinkhole Reimagined - June 14-September 2024 - The exhibit will document the events of February 12, 2014, when a sinkhole appeared inside the Museum, and focus on the countless Museum staff and supporters who reimagined the Museum that continues to evolve.

-LUSTER: Realism and Hyperrealism in Contemporary Automobile and Motorcycle Painting - Through the end of 2024 - A traveling museum exhibition of over 55 paintings by nearly 15 of today's realists and hyperrealists who specialize in automobiles and motorcycles as their primary subject.

-American Love Affair: 70 Years of Corvette - Open through 2025 - Located in the Museum Skydome, the Skywall, is an 8.5 ft. tall, nearly 300 ft. long LED screen that presents a jaw-dropping continuous video moment that captures the energy, sight, sound and experience of Corvette.

-Corvette Cave-In - Opened in February 2016, the exhibit tells the story of what happened the day of the sinkhole, why it happened, what cars were affected, how they were recovered, how the building was fixed and much more.

MUSEUM GALLERIES

-The McMichael Family Education Gallery - Opened April 28 - This gallery provides a state-of-the-art educational experience geared directly to the next generation of Corvette enthusiasts engineers, designers and more.

-E. Pierce Marshall Memorial Performance Gallery - This gallery showcases the exciting history and cutting-edge advancements of Corvette performance through dynamic multimedia presentations.

-Nostalgia Gallery - Enjoy a journey through the iconic eras of Corvette history, showcasing classic models and memorabilia that demonstrate the timeless appeal and cultural impact of the Corvette.

MOTORSPORTS PARK

-Drive the E-Ray - Get behind the wheel of a Corvette E-Ray for four (4) lead/follow laps on

the NCM nationally recognized road course.

-Corvette Touring Laps - Drive a C7 Stingray or a C8 mid-engine Stingray in a lead/follow format for four exciting laps. Enjoy the challenging turns, straights, and elevation changes.

-Camaro Touring Laps - Camaro fans can drive a Camaro SS, equipped with a 455 horsepower engine paired with a ten-speed automatic transmission, Magnetic Ride Control, Performance Traction Management and Performance Exhaust.

-Front V. Mid Engine Experience - As a comparison, drive both a C7 and a C8, each for four (4) laps, in a lead/follow format on the park road course.

-Stingray V. Z06 - Drive a new Stingray Z06 to test the power and performance by driving four (4) laps (above highway speeds) in a lead/follow format around the 3.2 mile, 23 turn road course.

-Corvette V. Camaro Bundle - Drive a C8 Stingray and a Camaro SS1LE, each for four (4) laps on the park road course in a lead/follow format.

-Bowtie Bundle - To experience all three GM sports cars, drive C7 and C8 Corvettes and a Camaro SSLE, each for four(4) laps, on the park road course.

David Harold Shadbar

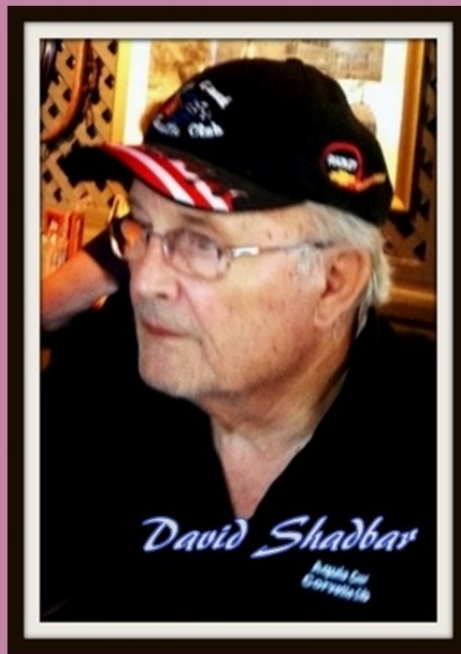
December 17, 1940 - April 29, 2024

Willing Warriors – Continuing Needs

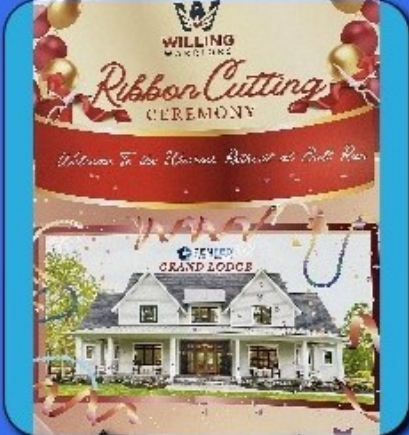
How ACCC Members Can Help

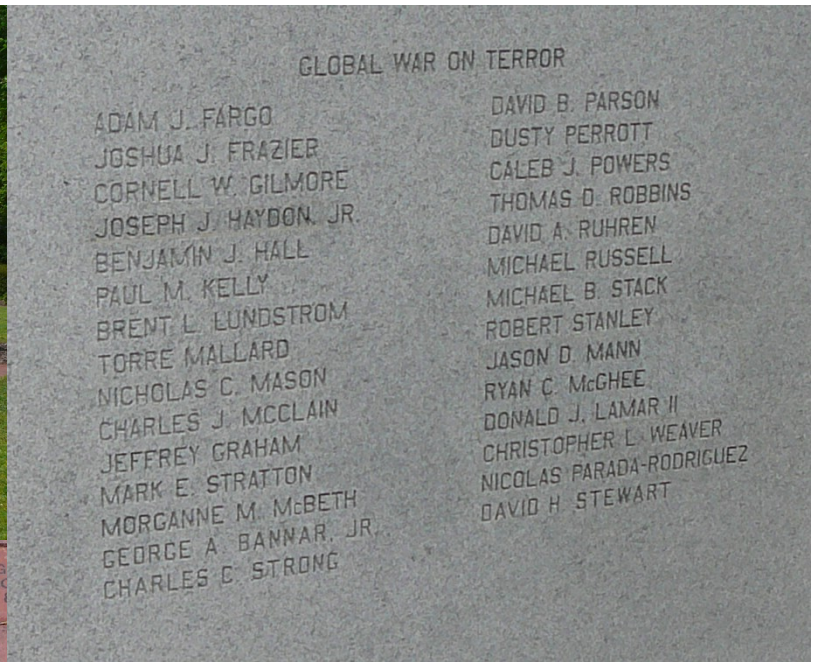

Fredericksburg Area War Memorial Park

Memorial Day, May 27, 2024

On May 3, I took my Corvette out for a photo opp (one of the photos I took appears on the cover of this newsletter). I chose the Fredericksburg Area War Memorial Park. The city of Fredericksburg, in conjunction with the Fredericksburg Area Veterans Council, established the park. Its purpose is to honor area service members who gave their lives in WW1, WW2, Korea, Vietnam, and the global war on terror. The words "Our Fallen Heroes" sit atop the columns, which have the names of those who died inscribed on their sides, grouped by the applicable conflict. Among those lost to the Global War On Terror are Joshua Frazier, Nicholas Mason (Frazier-Mason Foundation), and Robert Stanley, son of former Shannon Airport co-owner Robert Stanley, Sr. In front of the memorial sits a WW2 40mm anti-aircraft gun. The brick sidewalks are engraved with the names of those who served. The city holds ceremonies there to honor those who made the ultimate sacrifice for their country. On Memorial Day, May 27, 2024, I returned to the park to attend the Memorial Day ceremony held for Fredericksburg area veterans and residents to honor those who sacrificed all so that we could remain free. Surprisingly, and fortunately, the rain held off. Attendance was good, considering the potential for inclement weather -- about 100-150 people were present. After the ceremonies at Indianapolis and Charlotte the day before, this modest ceremony speaks well of Fredericksburg.



What I Did to My Corvette

Dave Jones — 2006 and 1996 Corvettes

I purchased my 2006 late in 2023 and had not had an opportunity to take it out for an extended period time. On Saturday, April 13, I invited a friend and we drove over from Stafford to Culpeper to visit the Commemorative Air Force Hangar at Culpeper Regional Airport. The hangar houses and maintains some WWII aircraft and memorabilia and is open for guided tours on Saturdays during April. As it turned out the weather was perfect, although a bit windy. We toured the facility and had a nice lunch at Uncle Elder's BBQ (thanks Skip for the recommendation) in downtown Culpeper. We enjoyed the outing and chance to get to know my 2006. It performed well and met or exceeded my expectations.

On Sunday, April 14, I decided to take my 1996 out of winter storage. I removed the covers, checked fluids and tires, gave it a quick hosing and took it for a short drive. All seems well. [Update: The 1996 is now for sale and has new tires. See the ad on page 25.]



What I Did to My Corvette (cont'd)

Steve Argubright — C8 — A Short, Long Story

I am very happy to report that after **five weeks** at the Chevrolet dealership (with plenty of alibis and excuses), my C8 is finally back in my garage with a new transmission control valve body..

To make a long story short, the dealership found harsh downshifts when stopping and delayed engagement on acceleration. A sticking valve in the valve body was discovered. The valve body was replaced. It now runs just like new. If the valve body didn't correct the problem, a new transmission would be in my future. In all, it would have been a very expensive repair had it not been for the warranty!

Here's a tip. I found the Chevrolet Customer Assistance line (800-222-1020) very helpful. They asked for the VIN, dealer's name, miles on the vehicle, and a short description of the problem. They assigned a case number and contacted the dealer directly, after which things really got moving!! They followed up via phone with me twice, including the day the car was done and ready to be returned.

But Wait, There is More!!!!

Having retrieved my C8 on May 13, I decided to treat myself to a short day trip. So, on May 19 I fired it up, only to be greeted with an OnStar message that the right rear tire had a pressure of 11 psi. So, back to the dealer on May 20, where a nail was discovered in the tire. The dealership decided to replace both rear tires for safety and reliability. Fortunately, at the time of purchase, I bought the dealer's tire/wheel replacement package, so the two new tires were free!!

What I Did to My Corvette (cont'd)

Jim Martin — 2023 C8 Coupe

I replaced my stock air filter with the Attack Blue air filter. It's supposed to add at least 10 hp.



Skip Sizemore — 1995 C4 Coupe

My 1995 C4 Corvette had been having starting issues for months and had been admitting a strong gas smell after being started. The C4 would always start, but it was a difficult process getting there. When the car had been sitting for a few days it would start almost immediately. However, after running for a while and being turned off it did not want to restart without pressing the gas pedal to the floor and holding it there. However, often this starting method would result in a fuel fouled spark plugs. Not good because it adds to the diagnostic difficulty.

Turns out the culprit was a leaking fuel pressure regulator. I had thought when this problem first started that I had a dying fuel pump. After all, the Corvette has one hundred thirty thousand miles on the odometer. The fuel pressure regulator on the 1995 LT1 is located on the top rear area of the engine on the driver's side. On my car it was covered by the fuel tail/injector cover (see photos). After replacement, the Corvette is running smoothly and starting quickly just like it always has. The tip off to where the problem was coming from was the strong smell of gas. Dying in-tank mounted fuel pumps do not give off a raw fuel smell. A careful visual check of the engine was all that was needed to find the problem. Hope this helps someone.
